Inaugural Session:

After the registration of participants, Inaugural Function of the 15th National IT Seminar on "Cyber Security – Issues and Challenges" was arranged in the Auditorium of MERI College. After welcome of the chief guest, eminent dignitaries and all guests witnessing the event; lightening of lamp was performed by the chief guest and other dignitaries.

Sh. I.P. Aggarwal, Founder President presided over the inaugural function. Prof. Arvind Kumar, Vice- Chancellor, Rani Lakshmi Bai Central Agricultural University, Jhansi was the Chief Guest along with other dignitaries Prof. Lalit Aggarwal, Vice President & Director, MERI; Prof. Y. L. Grover, Director General MERI; Sh. Shiv Kumar, Vice President Region – I, CSI; Sh. Yudhister Sharma, Chairman, CSI, Delhi Chapter and Dr. R.C. Goyal, Dean(IT) MERI were present on the dais. To convey emotions, all dignitaries on the dais were felicitated with bouquet presentation by the students of MERI College. On behalf of MERI Group of Institutions Sh I. P. Aggarwal, Founder President welcomed the chief guest and all the dignitaries present in the auditorium and narrated the importance and necessity of Cyber Security for the society.



The Chief Guest, Prof. Arvind Kumar, Vice-Chancellor, Rani Lakshmi Bai Central Agricultural University, Jhansi inaugurated the seminar. Prof. Kumar highlighted various issues and expressed that IT is becoming a necessity to provide latest technology to everybody in the world. Flow over sophisticated cyber-attacks are on rise, targeting social networking and institutional sites, corporations and financial institutions, besides attacks on intellectual property, sensitive data media outlets /de-facing organizations. The valuable asset is increasingly under attack affecting the business network and also putting national and economic security at risk. The recent survey of corporates by Lloyd's of London found that cyber-crime ranked 3 among the risk contributing global businesses. NATO has included cyber space as the fifth domain of war in the organization Article V, clause on collective defense.

He also narrated that the growth of cyber-crime is due to global diffusion of the Internet with hi-speed broadband system, the ascent of mobile technology and cloud computing which has expanded the volume of sensitive business and information and the growing technological sophistication of cyber, cyber-attacks and have no physical boundaries. Often it is difficult to detect and respond timely for which efficient security system are needed to pre-empt or withstand these attacks.

He opined that Cyber-attacks can be minimized through International legislations against such crime, enhance Research and Development and reforms in Federal information management act of 2002. There is also need of public awareness and education to adapt essential internet security practices and to ensure protect against attacks. The cybercrime cost is highest in Germany and the cyber-crime is also growing in emerging economies where Internet penetration is rising with weak regulatory and legal structures. The Global annual cost of cyber-crime may be 15-20 % of the value of Internet related business worldwide. But the actual economic costs may be still higher due to under-reporting of cyber-attacks. The cyber-crime also creates major commercial opportunities for providers of cyber products and services. The market for cyber security has been estimated to be about 58 billion dollars. This includes equipment, consulting services, policy supports, web management, Internet firewalls, forensic analysis and human resource management and governance to cope up with the mounting cyber threat. In the years to come adequate investments are therefore needed for the cyber security and management including capacity building programmes in this area.



After inaugural address of the Chief Guest, Sh. Shiv Kumar, the Guest of Honour & Vice President Region – I, CSI, addressed the participants and explained the role of CSI in development of IT. He emphasised that everyone should be the member of CSI to join hands to meet the challenges of Cyber Security. Since 2015 is the Golden Jubilee year of the Computer Society of India (CSI) and the 50th Golden Jubilee Annual Convention is being organized by CSI Delhi Chapter during 2-5 December 2015 at India International Center New Delhi. He invited and requested to participate in the 50th Golden Jubilee Celebrations.

Sh. Yudhister Sharma the Guest of Honour & Chairman, CSI, Delhi Chapter thanked the MERI management for jointly organising the National Seminar and suggested to have similar activities in the future and also requested to join 50th Golden Jubilee Celebrations of CSI being organised by CSI, Delhi Chapter in Delhi.

Sh. I.P. Aggarwal, Founder President, MERI felicitated with a memento to Prof. Arvind Kumar, Chief Guest of the function. Prof. Lalit Aggarwal, Vice President & Director, MERI felicitated Sh. Shiv Kumar, the Guest of Honour & Vice President Region – I, CSI and Prof. Y. L. Grover, Director General MERI felicitated Sh. Yudhister Sharma, the Guest of Honour & Chairman, CSI, Delhi Chapter with a memento.



Prof. Y. L. Grover, Director General MERI proposed a vote of thanks and invited the participants to join over a cup of tea.



Technical Session I: Deliberations by Eminent Invited Speaker Lt Vineet Kumar, President, Cyber Peace Foundation, Ranchi, Jharkhand.

Keeping in view the Make in India program of Sh. Narinder Modi, Prime Minister of India, Lt Vineet Kumar, former CTO & Head, Cyber Defence Research Centre (CDRC), Jharkhand Police delivered his interactive session where in broadly the Cyber threats, Cyber Defence & operations, Case studies & Advisories were covered.





He discussed major terminologies like Vulnerability, Honeypot, Botnet (Bot + net) - Malicious Programs Vulnerability and Hacker VS Cracker in his talk. He demonstrated about, How Cyber Criminals Hack in? All the general steps that a hacker adopts; like he Locate the victim host by some scanning program; Identify the victim host vulnerability; Attack the victim host via this vulnerability and after break-in, use this victim host to hack or attack other network. He discussed various real case studies and also demonstrated about hacking at ATM machines.

He expressed that Hackers have lots of knowledge & experience and they are good guy and have strong ethics, never indulges in crime and catches the computer criminals where as Crackers have lots of knowledge & experience, but they are bad guys have low ethics and mostly indulges in Crime. The Crackers are Computer Criminals. Finally, he advised the students that they may opt for cyber security for their career.

Technical Session II: Deliberations by Eminent Invited Speaker Sh. Ravi Vijayvargiya, Sr. Technical Director & HoD, Network Security Division, NIC(Hq), N. Delhi

Shri Ravi Vijayvargiya who is a Cyber Security expert with graduation in Electronics engineering and postgraduation in Digital Communication engineering, delivered an interactive talk on Security Concerns for Student Community. He explained how the students and the youth together represent the largest user segment of the Internet in the country. The major cyber security concerns, this particular user segment must pay attention to, are pertaining to privacy, system infection and malware distribution. How loss of privacy and system compromise may affect the students was described. Social networking sites thrive upon millions of people voluntarily divulging accurate personal information. Lack of awareness may lead to compromise of the systems and malware distribution. The measures for safer browsing of Internet, password security and mobile security were also deliberated upon. During interaction the students raised several issues regarding malware.



Technical Session III: Deliberations by Eminent Invited Speaker Dr. R.C. Agrawal, ARS, Registrar General Protection of Plant Varieties & Farmers Rights Authority, Ministry of Agriculture, Govt of India, New Delhi

Dr. R.C.Agrawal, who is an IT expert and has PG Diploma in Cyber Law from Indian Law Institute, Delhi delivered talk on Cyber Law: Necessity in cyber space.

He described cyber law as that branch of law that deals with legal issues related to use of inter-networked information technology and briefly can be also known as that law which governs computers and the internet. The knowledge of Cyber Law becomes more important in today's world as the Internet has entered in everybody's day-to-day life and the use of Internet for e-commerce is increasing through a geometric progression.



With the increased use of Internet, many kinds of Cyber crimes like Stalking, Frauds, Pornography, Cyber Squatting have also evolved. The Indian Parliament passed Information Technology (IT) Act, 2000 in order to keep pace with the changing requirement for dealing with cyber crimes and to provide legal recognition for transactions carried out by means of electronic data interchange and other means of electronic communication, commonly referred to as "electronic commerce". This Act also facilitates electronic filing of documents with the Government agencies. He also discussed about the IT Act Amendments 2008 and some case studies of Cyber Crimes, the various provisions of Cyber Contraventions and Cyber Offences.
