Committee for Schedule Castes and Schedule Tribes

Officially recognised as historically disadvantaged groups, the Scheduled Castes (SCs) and Scheduled Tribes (STs) are a group of people in India. The Indian Constitution recognises the terminology, and the groupings are classified under one or more of the headings. They were referred to as the Depressed Classes during a large portion of the Indian subcontinent's British colonial history. Following independence, the Constituent Assembly preserved the existing definition of Scheduled Castes and Tribes, directing the president of India and state governors to create a complete list of tribes and castes. Furthermore, quest for inclusivity could be quenched only with provisions enabling it. A centre for the advancement of SC and ST has been established by MERI Professional and Law Institute. The director of the college is in charge of the three members of the Committee. The Committee's primary goals are as follows:

1. Take extra steps to guarantee that SCs and STs are fairly represented in the college admissions process.
2. To serve as a Grievances Redressal Cell for SC and ST community members' employees and students.
3. To make sure that the Schedule Castes and Schedule Tribes (Prevention of Atrocities) Act, 1989's restrictions are strictly followed.
4. To gather data and reports about notifications that the Indian government has made on issues pertaining to SC and ST employment, education, and training across the nation.
5. To evaluate the data gathered and assess the reports and digests for the organization's needs.
6. To carry out associated tasks that impact the SC and St Community.

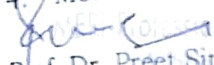
