This is in reference to your letter No. F.3(2)(8)/2025/Affiliation/8383 dated 28.03.2025 along with copy of JAC report for Issuance/Revalidation of Provisional NOC to Management Education and Research Institute, 52-55 Institutional area Janakpuri D Block New Delhi-110058 for the Academic Session 2025-26 seeking following courses/intakes :

As mentioned in the aforesaid letter dated 28.03.2025, the GGSIPU has examined the inspection report of JAC in respect of the above Institute. The JAC report in respect of the above said institute has been perused and it has been noticed that Part-I of the JAC report is more relevant in respect of land issues and statutory compliances of the institute and remaining Part-II & III of JAC report is related to academic matters including infrastructure and status of compliance with other terms and conditions pertaining to Institute. Since no documents have been attached/enclosed along with copy of JAC report forwarded by GGSIPU, hence it is presumed that the JAC headed by Retd. Senior Officers, other subject experts and representative of University as members have seen and examined all the relevant documents/statutory clearances as per policy guidelines issued by this Directorate during the inspection and recommendations have been made in accordance with policy guidelines.

Therefore, considering the facts above and based on the recommendations of JAC and GGSIP University, the provisional NOC for the following courses under DHE for the Academic Year 2025-26 is granted to Management Education and Research Institute, 52-55 Institutional area, Janakpuri D Block, New Delhi-110058 subject to the following terms and conditions :

3.	B Com (Hons.)	00/4Yrs

*It has been observed that the admissions are less than 50% of the sanctioned intake in BA(JMC) 2nd Shift during the last three academic sessions i.e. 2022-23 (120/02), 2023-24 (60/02) and 2024-25 (60/00) in the Institute, therefore, the Institute has been allowed to run this programme with half of the intake of the lastly sanctioned seat strength as per amended clause 4.1 of the Policy Guidelines amendment vide letter no. DHE.4(37)/GGSIPU/2020/1390-1411 dated 10.06.2021.

- 1) The Society/Institute shall abide by all the rules and regulations in force in Delhi by the Government, Local authorities and the affiliating University.
- 2) The Society / Institute shall follow the fee structure prescribed by the University/ Govt. of NCT of Delhi.
- 3) If it comes to the knowledge of Govt. of NCT of Delhi that the NOC has obtained by giving any false or misleading information or by concealing or suppressing any material facts or information, the NOC granted shall be withdrawn/ cancelled.
- 4) The University shall monitor compliance of the terms & conditions on a quarterly basis. If it is found during the course of monitoring of the compliance of the terms & conditions of grant of NOC, that the institute has not complied with these terms & conditions, the University may take penal action against the institute after following proper legal procedure.
- 5) The University may ensure the space norms prescribed by the Statutory Authorities/University/AICTE/UGC etc. are complied with.
- 6) The Institute/University shall strictly follow the policy guidelines prescribed by Directorate of Higher Education, GNCT of Delhi vide letters dated 12.01.2016, 03.02.2017 & 10.06.2021 in letter and spirit.
- 7) All the statutory compliances and removal of all other deficiencies/ shortcomings/suggestions noticed in the JAC report must be complied with by the concerned institute latest by 30th September, 2025. It is emphasized that the required precaution be taken immediately and all deficiencies removed in the given time frame failing which appropriate action as per guidelines/policy should be taken by GGSIPU under intimation to the Department.
- 8) Use of basement should be strictly based on MPD 2021 and rules made under UBBL 2016.
- 9) The GGSIP University must ensure the compliance of the same within stipulated time period.
